### **Chapters' News**

#### La Belle Vue #933 BELLEVUE

La Belle Vue #933 toured the "Mystical Mansion", a restored Historical Landmark in the Joslyn Castle district of Omaha. The tour of the 1910-built American Tudor styled house began on the com-



fortable front porch where the home's present owner, Kim Isherwood welcomed us. Kim did a wonder-



ful job of taking our group on a tour of the lovely home. During the tour, she discussed the ongoing restoration process and the journey she and her husband Ryan have been on to preserve the beauty and integrity of the

structure. The home was built by Ephraim Dixon who was the President of Orchard and Wilhelm. Orchard and Wilhelm was a high-end furniture and appliance store for decades on South 16<sup>th</sup> Street between Harney and Howard where the present OPPD headquarters is housed. The home is called the Mystical Mansion for as the fifth owners of the Gold Coast Mansion, Kim and Ryan have been uncovering its secrets. The Isherwoods have done most of the restoration themselves, while remaining faithful as possible to the original design by John L. Latenser, an early 20th century architect who did such Omaha projects as the Douglas County Courthouse and the Brandeis Building.

There are so many wonderful aspects of the house and its designs to notice, but a few outstanding ones will be mentioned. The grand foyer is so

welcoming with its three-story winding stairway, high walnutcoffered ceilings, double-wide original leadglass pocket doors, and perfectly preserved black and white mosaic floors. Kim told us that



the floors were one of the secrets that they found while removing wool carpet circa 1938 from the floors. The second floor has an enclosed small porch. The master bedroom dressing room has a floor-to-ceiling built in wardrobe with several built-in cabinets. As this writer walked into the linen closet, I discovered a lost list of pencil markings logging the heights and dates of the children who have grown up in the home. We were able to see all floors including the servant's quarters and all the six bathrooms of which many retain their original porcelain tiles and pedestal sinks. It was clear to all the Questers and their guests as we toured this remarkable home that the Isherwoods have not just restored this house, they have restored a treasure and this treasure is the place they call home. Kim says she and Ryan are "stewards" for this remarkable piece of history. Kim opens her home for special events, and we are so thankful she opened her home to La Belle Vue so that we could discover this Omaha treasure.

After touring the home, the group celebrated being together during the summer at a luncheon at La Mesa in Bellevue. The pictures show the group on the porch of the mansion, owner Kim Isherwood





standing by the Historic marker of the house, group standing on the staircase, and the dining room "safe," one of the treasures the Isherwoods discovered near the built-in buffet.

#### How the Landlocked State of Nebraska got its own Navy

In 1930, Nebraska Gov. Charles Bryan decided to take a little vacation, and while he was gone, he left Lt. Gov. T.W. Metcalfe in charge of the state. The power went straight to his head, and thus the Great Navy of the State of Nebraska was founded as a way for Metcalfe to appoint his friends as admirals. He did this even though - you might notice through the simple act of glancing at a map — Nebraska has absolutely no ocean access.

Despite the lack of necessity for standing maritime security forces, the Great Navy of the State of Nebraska continues. Those who have the title of admiral in the Nebraska Navy conferred upon them have absolutely no military authority whatsoever. The title is purely symbolic, like the Kentucky Colonels and the Rhode Island Commodores.

When appointed, admirals are given a certificate from the governor that reads, "And I do strictly charge and require all officers, seamen, tadpoles and goldfish under your command to be obedient to your orders as Admiral — and you are to observe and follow, from time to time, such directions as you shall receive, according to the rules and discipline of the Great Navy of the State of Nebraska."

"Many Nebraskans and visitors to our state have not heard of our Navy," the Nebraska Admirals Association wrote. "They have not heard of the waves of prairie schooners that at one time plied our plains under which lies our real wealth — Nebraska's under-ground sea."

Sounds corny, but what do you expect? It's Nebraska!

#### Corps of Discovery #1504 OMAHA

In May, Nancy and Roger Utman hosted a walking tour of the Prospect Hill Cemetery located at 3202 Parker Street in the Prospect Hill



neighborhood of North Omaha. Shannon Justice of History Walks LLC led the tour. Shannon did an excellent and entertaining tour. This cemetery is believed to be the oldest pioneer

cemetery in Omaha. This public cemetery was

established in 1856 and is presently owned by the Prospect Hill Cemetery Historical Site Development Foundation. It is 13.84 acres of land and is the resting place for over 15,000 citizens. Its founder was Byron Reed, an



early Omaha real estate developer and financier. Among the many prominent pioneer families, interred at Prospect Hill, there are also monuments to Spanish-American War veterans and the gravesite of at least one Buffalo Soldier, Sergeant Allen Mc Clare.

Ms. Justice imparted many interesting stories about such notable internments as Dan Allen gambler and businessman, and the many Mayors of Omaha and other Nebraska Statesmen whose gravesites are in Prospect Hills. Among the many things she pointed out was a special section of soldiers from Fort Omaha and the graves for at least 360 early African American Omahans. The cemetery was designated as a local landmark in 1979. After the tour, the members enjoyed food and fellowship at a local restaurant in the area.

In June, Bob and Lorraine Jeffus welcomed fellow members and guests to their lovely Georgian Revival Style home, Oakleigh, in Bellevue. Lorraine presented an interesting program on the restoration and preservation process of the home. The house was originally built by the Wilkerson family in 1920 and the two hundred acres of land was used as a sheep farm. In 1970, the home and seven acres of land were sold to the Wolfe family; in 1995, Bob and Lorraine purchased the home and 2 1/2 acres. Bob Perrin was the architect for the project which included a large addition of a kitchen and master bedroom suite. Lorraine explained the restoration process, some of which was the removing of the 1960's wallpaper, stripping oak fixtures such as crown moldings, baseboards, and doors. The removal of carpet and linoleum as well as ceramic tile uncovered beautiful oak floors. Many Georgian Revival design elements were utilized when the structure was built such as two stories, an all-brick structure in a rectangular shape and facade. The Corps enjoyed our tour and learned a great deal about what it took to make Oakleigh a home that is welcoming but also touches the past with grace.

In July, Chalice and Ben Harvey hosted. Ben gave a presentation of his recent trip to Norway. Ben presented photographs taken on his journey and concentrated his program on Operation Gunnerside: The Norwegian Attack on Heavy Water that deprived the Nazis of the Atomic Bomb. This heavy water production was taking place in a remote Vermork, Telemark in Rjukan Norway. Norsk Hydro began producing heavy water in 1934, and Norway became the first country with a commercial heavy-water plant.

The Nazi invasion of Norway in 1940 transferred control of the plant –and most of the world's heavy water to Germany. Ben gave a glimpse into Operation Gunnerside and the brave Norwegian Commandos who conducted with success, one of the most dramatic and important military missions of World II. An earlier attempt at the same mission by British soldiers had been a complete failure with the survivors being captured, tortured, and executed. The successful mission put the German nuclear science months behind and allowed the United States to overtake the German quests to produce the Atomic Bomb.

### Dedication of the Future Site of the Sarpy County Museum

Corps of Discovery #1504 and La Belle Vue #933 Questers Chapter's members were present at the Sarpy County Museum Site Dedication on June 27th, 2023 at 4PM. This dedication celebrated the acquisition of land located at the Southwest corner of Hwy 370 and 90th Street in Papillion, NE. This land will serve as the future site of the museum. In addition to addressing the issue of vastly outgrowing the current museum located in Bellevue, NE., the new building will house the nationally renowned Wimmer Railroad Collection. The preeminent private railroad collection acquired by Bill and Judy Wimmer during Bill's 50-year career in the railroad industry is comprised of more than 10,000 unique pieces of railroad history.

Community members and leaders gathered at the nearby Trinity Lutheran Church. Due to the windy conditions that prohibited meeting outside. Sarpy County Museum Executive Director Ben Justman (\*Corps of Discovery #1504 Member) said: "I'm excited about what the future holds", It's a very important and special objective in the fastest growing county in Nebraska that we can set aside a parcel of land here to continue to tell the past and continue to tell the stories of the history being made, even today." Representatives from all five Sarpy County cities, as well as the county government, gave remarks and shared their excitement for the museum. Scott Wimmer, whose parents donated the Wimmer Railroad Collection, was among those who spoke. Wimmer stated that preserving the traditions and heritages that developed the county such as the impact of the railroad is important. Many thanks went out to the Wimmer family for the donation of this generous addition to the museum.

At the new site, the museum plans historical information and artifacts in five broad areas: the history of early residents, agriculture, transportation, the military, local communities, and as stated before, The Wimmer Railroad collection. The Questers and the museum have a long history of cooperation as La Belle Vue and Corps of Discovery have worked to get grants for the restoration of many artifacts.

Early on, La Belle Vue #933 helped to restore the Log Cabin built in the 1830's which hosted the first twins born in Nebraska Territory. Most recently the two Chapters have cooperated in obtaining a grant from the Nebraska State Questers for the restoration of the 1869 Omaha and Southern Railroad depot windows. The Depot is housed at the museum.




Rendering of Sarpy County Museum site plan

#### WHAT IS A QUESTER?

The year 1944 was full of misery for many people. Everyone was so weary of the War, and many had lost loved ones. Morale was slipping, and anything that would give it a boost was needed. This is what Jessie Elizabeth Bardens, who was a Red Cross production chairman living in Fort Washington, Pennsylvania, had in mind when she asked a group of her co -workers to come to her home. They were to "bring an antique and a sandwich." She had purchased a little blue syrup pitcher from a shop near work in October 1943. On her way to and from work, what would be more natural than to stop at an antique shop if you were passing by?

After showing this pitcher to her co-workers and discussing it, others stopped by her desk and more questions were asked with still more discussion following. This started a whole stream of small antiques being brought to work by her co-workers, just so Mrs. Bardens could give her opinion on them. This convinced her something was needed. So on April 6, 1944, she invited fourteen people to come to her home for more discussion and study. By the end of that year, there were 35 people meeting to learn more about antiques. At this time, most homes could not accommodate this many people, so Mrs. Bardens encouraged all those wanting to join to form their own study groups. Before long, there were five more groups. In March 1950, Mrs. Bardens organized these six groups into a national organization and in 1953 incorporated it under the laws of the Commonwealth of Pennsylvania as a non-profit corporation. Mrs. Bardens was the first National Quester President, serving from 1950-1956.

The word soon spread, and inquiries came from all over the country about forming chapters, as well as how to affiliate existing antique clubs with this national organization. Mrs. Bardens personally went where she could to organize these groups, the rest she did by mail. She always made it a point to answer all questions. In 1954, she and her husband drove as far west as lowa, organizing chapters as they went.

Mrs. Bardens had a large and choice collection of tea caddies that she was frequently asked to talk about. She gave a friend, the National President from 1964-1966, a sterling silver tea caddy. Years later, it was given to the Quester Headquarters in Philadelphia. The sterling tea caddie is part of Bess's tea caddie collection that is on display at headquarters.

Before Mrs. Bardens passed away on Christmas Day, 1963, she was able to attend the first National Quester Convention and see the Questers organization grow to 149 chapters located in 22 states. Now, there are around 500 chapters in 36 states and 2 Canadian provinces. With the addition of the Canadian chapters the questers earned the right to add "International" to their name in 1991. The organization promotes preservation and restoration of memorials, historical buildings and landmarks, and any money earned must be used for these purposes. The Questers is a non-profit organization.

International Bylaws and Policies along with State and Chapter policies govern The Questers. There are International, State/Provincial, and Chapter Officers who are elected by the membership. Any Quester who meets prescribed criteria can become an officer - individuals may be nominated for office from their credentials but primarily due to work done in their chapter and state/province.

The size of each chapter is governed by Chapter Policies, with a minimum of six members needed for a chapter to be chartered per International Bylaws. The number of members is often limited by the size of the members homes where meetings regularly occur. The Questers Bylaws and Policies do not require a minimum number of members to continue as a chapter.

When Mrs. Bardens was asked, "What is a Quester?" she gave this answer: "A Quester is a socially welladjusted intelligent person who has curiosity, enthusiasm, imagination and a good memory. For the powers of the mind are memory and imagination, for without memory we have no past, without imagination, no future." She also said, "A Quester spends time constructively, does research about the history of antiques and collects knowledge. Sooner or later the 'Bug Bites' and they have acquired a hobby and are a collector."

#### ADDITIONAL HISTORY OF BESS BARDENS AND HER QUESTERS ORGANIZATION

1. Bess Bardens, founder of THE QUESTERS, invited 14 ladies to her home on April 6, 1944. That was the date of the first meeting.

- 2. In March 1950, she organized several Questers clubs into a National Organization.
- 3. The first Newsletter was printed in October 1951.
- 4. First Convention was at the William Penn Inn in Gwynedd, PA, in April 1952.
- 5. In February 1953, THE QUESTERS was incorporated as a non-profit organization.
- 6. Bess died Christmas day, 1963.
- 7. The first Canadian chapter was chartered on October 23, 1967.
- 8. Our HQ house was purchased on October 27, 1967.
- 9. Our Scholarship program started in 1973.

10. We finally started calling ourselves an International organization in 1990. (We had had several Canadian chapters starting in 1967!)

- 11. Our Fellowship program started in 1997.
- 12. Michigan was the first state to sign a charter as a State Organization.

Bess Bardens, our Founder, had started about 6 "clubs" when she got the idea of forming a national organization. The first one she formed in April 1944 was called Countryside, and Heritage was the 6th. She was a very organized person, and she had all her ducks in a row before going out to present her idea to the various clubs. She was so excited to "inform" everyone that they were now going to be a national organization and have a convention every year in a different state and the officers would be "required" to attend. She had done all the work. All they had to do was vote "yes." It was shortly after the war, and many of them had young children and could not afford to travel to other states. She came across as a bull charging through a china shop and they were overwhelmed. When the vote came, they all voted NO. She was stunned. This was her own club, Countryside. She marched out, and they did not speak for ten years.

She went to club after club after club and they all voted NO until she reached the last one: Heritage. They voted to go with her, and that is how Heritage became Chapter #1 of THE QUESTERS. She quickly organized Chapter #2, Wissahickon as her own new chapter, followed by Tredyffrin #3. Heritage is still an active chapter, Wissahickon disbanded years ago, and Tredyffrin, unfortunately, disbanded in 2020 after celebrating 70 years.

Interestingly, Countryside Questers continued to meet on their own---not as part of Bess's new Questers---until sometime after 2000. I interviewed Peg Dando who was one of the 14 original invitees. She had missed that first meeting because her daughter was sick. That daughter eventually joined Questers too. Peg went to live at a retirement home, and after Countryside quit meeting because there were only 2 left and the other lady either died or became too ill to continue, she finally joined Bess's "new Questers" (a chapter that met at her retirement home). Three other original clubs eventually disbanded because I could not find a trace of the other original clubs except for one: Heirloom. They were still meeting (all by themselves) in 2009. I have not inquired to see if they are still meeting.

Little did Bess know that her little antiques club would eventually extend to 48 states and 2 Canadian provinces. The only states that have never had a Questers chapter are Vermont and Hawaii. We are now an International organization and we have donated over a million dollars for preserving and restoring historic homes and sites and artifacts in museums across two countries. We have helped students with scholarships and fellowships, and they have gone out in the world and accomplished so much in the field of preservation.

I think Bess's dream has been realized and then some!!! I think she would be proud.
